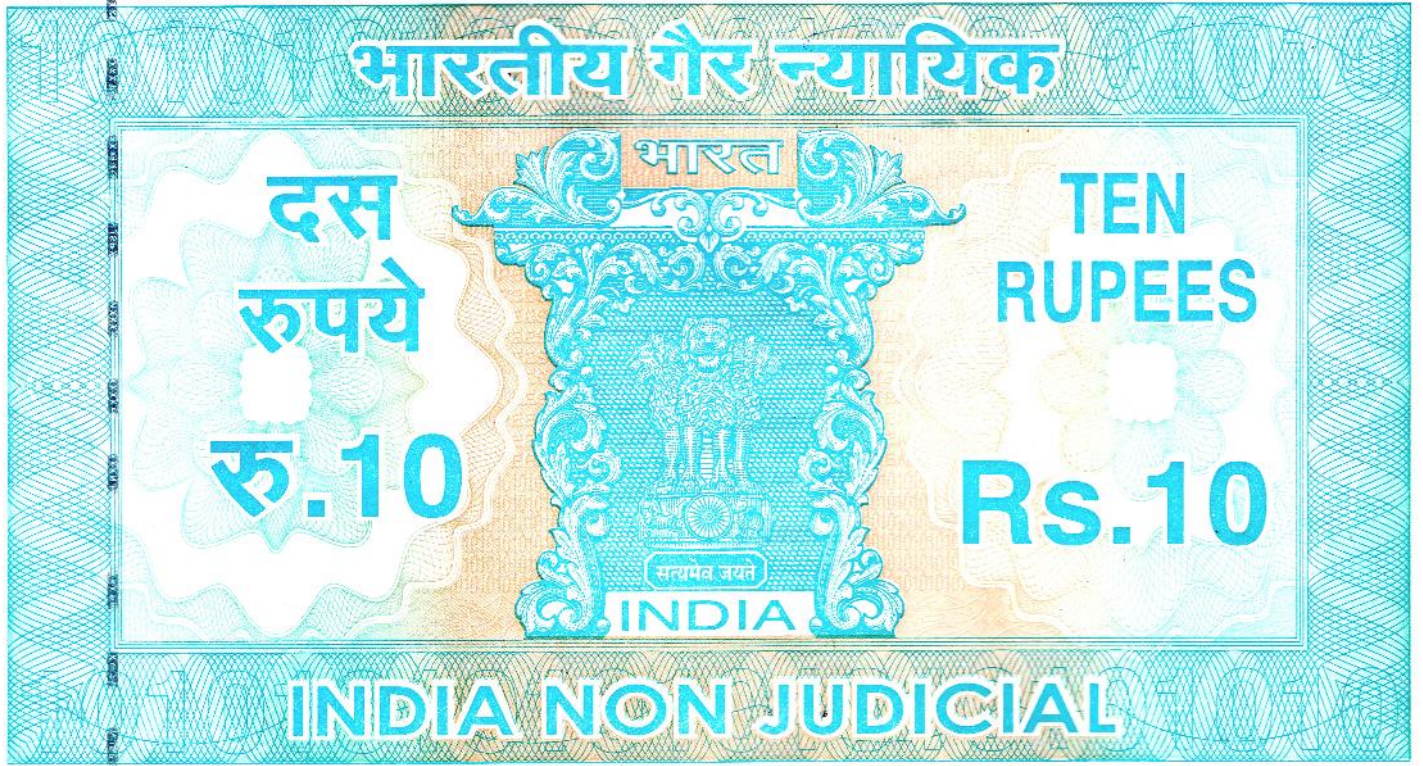

- I. The **Purpose** of this Memorandum of Understanding is to recognize the roles and responsibilities of both the parties - Entity 01 & Entity 02 and to understand and agree to the Terms of Use & Privacy Policy (as defined from point no. IV).

In particular the Memorandum of Understanding is intended to:

1. Establish the roles and the responsibilities of both the Entities.
2. Define the timeline of the project
3. Recognize the people involved
4. Enhance the functionality of the Entities
5. Understand the Scopes of State, National & International Publicity of Projects & Programme, designed, planned, executed and documented by both the Entities.

II. **Background** of the parties involved

Shri Shikshayatan College (Entity - 01) emerged as a Educational Institution. It was founded on 8th July, 1955 for girls under affiliation to the University of Calcutta. Established by the Marwaris, a linguistic minority institution, it is administered and managed by Shikshayatan Foundation (Formerly Marwari Balika Vidyalaya Society - registered under the Societies Registration Act) which runs it solely for educational and not for commercial purposes. As a linguistic minority institution, it enjoys protection under Article 30(1) of the Constitution of India. Originally meant for imparting and promoting education among the girls of the Marwari community, it has over the years, opened its doors, in response to pressures for admission, to all eligible girl students irrespective of caste, creed, religion or language.

The College aims at imparting liberal education which helps in developing the total personality of students and bringing about all-round growth of their personality and making them self reliant. The College Research Committee which was formally formulated in 2014 is deeply committed in promoting research activities among faculty members and students. It helps to engage faculty members and students in quality research projects and encourage them to publish papers in reputed journals, thereby generating confidence and interest in the outside universities and institutions to establish productive linkages with the college. The college is committed to maintaining a good academic standard in a non- politicized environment.

WildRoots (Entity - 02) is registered as a Society under the Societies Registration Act XXI of 1860, India, based in the City of Guwahati in the State of Assam, India. It primarily plans, executes and documents Projects and Programmes related to Climate, Environment & Bio-diversity Awareness that involves, inspires and encourages students from Educational Institutions (from both the Urban&

Rural Sectors - that include Schools and Colleges) into engaging themselves into actions and activities related to Conservation. The organization has developed a platform to work towards achieving the vision of a "Clean, Sustainable Environment & Climate" by striving for **environment conservation, climate, environment, bio-diversity awareness, conservation education and climate change mitigation**. Pursuant to its vision, the organization partners with **academia, art, business, civil society, finance, government, media, movements and third party, multilateral organizations, on the State, National & International Levels**, working in philanthropy and policy.

III. Services overview

As per this Mandates, both Entities will develop a platform to work towards achieving the vision of a "Clean, Sustainable Environment & Climate" by striving for **environment conservation, climate, environment, bio-diversity awareness, conservation education and climate change mitigation**. Pursuant to a joint vision, the Entities would partner and engage themselves in activities connected with **academia, art, business, civil society, finance, government, media, movements and multilateral organisations** working in agreement and collaborative action plans. In line with the work carried out by both the Entities, the Participants and Users of the Projects and Programmes (at their own discretion) have the **option** of receiving updates on the work carried out by both the Entities or understand and uphold the collaborations entered into by both the Entities, by visiting the Websites or by contacting the 'Primary Contacts' of both the Entities. All Services jointly planned and executed by both the Entities will be through Collaborative Ventures.

IV. Definition of Primary Contacts of both the Entities, under this MoU

Dr. Aditi Dey, Dr. Jayati Das & Dr. Illora Sen will be the Primary Contacts for Shri Shikshayatan College

Dr. Biswajit De, Founder President, WildRoots, and Mr. Sutirtha Lahiri, Secretary, WildRoots, will be the Primary Contacts for WILDROOTS - India

Note: Entity - 02 will not engage into any personal relationship with the Points of Contact of Entity - 01, and will not initiate and encourage any activities through the payment of any remuneration for any services that are rendered. Likewise, Entity - 01 will not engage into any personal relationship with the Point of Contacts of Entity - 02, and will not initiate and encourage any activities through the payment of any remuneration for any services that are rendered, other than any '**Subscriptions for Organizational Memberships**' which are defined below.

All Communications, in sync with this MoU will only be entertained and recognized when the above mentioned are involved. This MoU will not recognize any communication from/between anyone, other than the abovementioned.

7. Coordination and communication with the Primary Contacts, as defined before.
8. Conducting and organization of the focus group discussions that involve Students and Faculty Members from Entity - 01, to discuss Projects and Programmes.
9. Review of Reports and publicize collaborative projects jointly planned, executed and documented by Entity - 01 and Entity - 02.
10. Compile a End of the Year Report of all Activities.
11. Networking and coordinating with Government and Non - Government authorities to procure information and permissions related to the projects and programmes, jointly planned, executed and documented by Entity - 01 and Entity - 02.
12. Publish Reports, Journals and Newsletters that showcase the Collaborative work.
13. Give permissions to Students and Faculty Members and encourage their participation in Excursions, Field Trips, Voluntary or Paid Internship Opportunities designed by Entity – 02
14. Encourage Students and Faculty Members to Bear expenses (Personal/from their own) related to the projects and programmes and subscriptions defined by Entity - 02, as per actual.
15. Supporting, Encouraging, Monitoring and Mentoring all Projects and Programmes planned, executed and documented by Entity - 01 &/or Entity - 02

Privacy Policy - Applicable to both Entity - 01 & Entity - 02

 - Each Party shall retain all rights to its IP and nothing contained in this MOU, nor the use of the IP in the publicity, advertising, or promotional or other material relating to the fulfillment of the obligations of the Parties contained herein shall be construed as giving to any Party any right, title or interest of any nature whatsoever to any of the other Party's

IP.

- Partner institute will not copy or reproduce in any form, WOF's IP.
- The WOF licensed Intellectual Property is a product of WOF's knowledge and substantial skills, intellectual efforts and funding, and is, as such, a valuable asset, but is provided herein free of cost to the Partner Institute under the terms of this MOU.

3. Representations and Warranties:

- Each Party hereby represents and warrants that the use of IP made available or contributed by it does not violate the IP rights of any third party.
- Each Party has all requisite power and authority to enter into this MOU and the execution, delivery and performance by such Party of this MOU has been authorised by all necessary and appropriate corporate or governmental action and will not, to the best of its knowledge, violate any applicable law or approval presently in effect and applicable to it.

4. Confidentiality:

- The Parties acknowledge that during the term of this MOU each Party may obtain confidential and/or proprietary information of the other Party including, but not limited to, financial or business information, contracts and employee details (collectively, "Proprietary Information"). Such Proprietary Information shall belong solely to the disclosing Party. Proprietary Information shall not include information that is or becomes publicly known through no wrongful act of the receiving Party.




Role of the College:

- College will nominate one faculty member on behalf of them to coordinate with SAIARD and its activities

- College may carry the name and logo of SAIARD in its reports/any publicity materials on prior permission basis.

Role of the SAIARD

- SAIARD will help college in organizing value added courses/certificate courses as per the need of the college by providing required resource persons with necessary funding agencies.
- SAIARD will help in organizing capacity building workshops for both students and faculty members.
- SAIARD will facilitate student and faculty exchange programmes.
- SAIARD will assist college in organizing environmental awareness and gender sensitization programmes.
- SAIARD will carry the name and logo of College in its reports/any publicity materials on prior permission basis

NUMBER OF ACTIVITIES TO BE CONDUCTED:

During the tenure of MOU both the parties will organize a minimum of one capacity building workshop, faculty exchange programme for staff, student exchange programme, environmental awareness and gender sensitization programmes and two Certificate and Value added courses throughout the year.

FINANCIAL LIABILITIES

There will be no financial burden on both the parties. In case of student and faculty exchange programmes the cost will be borne by respective participants. Both college and SAIARD will work to get funds from funding agencies such as ICSSR, UGC, MOES, CSIR etc. In case if both the parties are jointly carrying out a joint project the financial terms will be decided by both the parties based on the cost of the project.

PERIOD AND APPLICABILITY

Unless terminated earlier as per the provision herein contained, this agreement shall be valid for an initial period of 05 (five) years from the date of signing this MOU. Subsequently, this agreement may be renewed for such further term or terms as may be mutually agreed upon.

TERMINATION

This agreement is valid till terminated by either party under mutual understanding. Either party may terminate this agreement at any time by giving ninety (90) days written notice. Projects, which may be undergoing and/or have been undertaken, should be completed before termination of the agreement.

GOVERNING LAW AND DISPUTES



Financial structure of the UR:

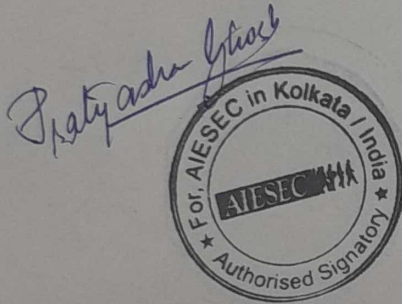
