





- The award of fellowship is to be availed by the teacher concerned subject to the condition that the teacher fellow is not having any on-going Minor Research Project and that he will not undertake any other research project during his tenure of FDP.
- In case, at a later date, the details given in the application form were found to be incorrect and/or some deficiency in the Selection Committee proceedings, the above award will be withdrawn.
- The tenure of Teacher Fellowship under 'Faculty Development Programme' for doing M.Phil is one year and for completing the Ph.D is two years.
- The fellowship grant will be sanctioned on receipt of Joining Report and statement of expenditure in prescribed proforma as given in the guidelines. This may be sent to UGC.
- The approval and sanction in respect of the substitute teachers to be appointed in place of teacher fellows will be conveyed on receipt of all documents as prescribed in the UGC guidelines for Faculty Development Programme.
