5. This Agreement will remain in force for three years (duration of six Semester sessions) from the date of signing, unless it is terminated by either institution with a minimum of one month's notice to the other institution.
6. This Agreement may be extended after discussion by the representatives of both the institutions.
7. In this MOU, there will be no financial involvement on the part of both the Colleges.
8. This agreement is executed in duplicate. An original copy of the agreement is to be kept in the custody of each of the Institutions.


**Effective period of the Memorandum:**
